An
Ordinance

to amend the Lahore Development Authority Act, 1975.

It is expedient to amend the Lahore Development Authority Act, 1975 (XXX of 1975) for the purpose of confining the jurisdiction of Lahore Development Authority to Metropolitan area of Lahore, and for the ancillary matter.

Provincial Assembly of the Punjab is not in session and Governor of the Punjab is satisfied that circumstances exist which render it necessary to take immediate action.

In exercise of the powers conferred under clause (1) of Article 128 of Constitution of the Islamic Republic of Pakistan, Governor of the Punjab is pleased to make and promulgate the following Ordinance:

1. Short title and commencement.- (1) This Ordinance may be cited as the Lahore Development Authority (Amendment) Ordinance 2021.

(2) It shall come into force at once.

2. Amendment of Preamble.- In the Lahore Development Authority Act, 1975 (XXX of 1975), for brevity referred to as ‘the Act’, in the Preamble, for the words “area of Lahore Division”, the words “Metropolitan area of Lahore” shall be substituted.

3. Amendment of section 1 of Act XXX of 1975.- In the Act, in section 1, for subsection (2), the following shall be substituted:

“(2) It shall extend to such area as may be notified by the Government as Metropolitan area of Lahore.”.

4. Amendment of section 2 of Act XXX of 1975.- In the Act, in section 2, for the words “Lahore Division”, the words “Metropolitan area of Lahore” shall be substituted.

5. Amendment of section 3 of Act XXX of 1975.- In the Act, in section 3, for clause (c), the following shall be substituted:

“(c) “area” means Metropolitan area of Lahore;”.

6. Amendment of section 4 of Act XXX of 1975.- In the Act, in section 4, in subsection (3), in clause (b), in sub-clause (i), the expression “, not more than one from each district of Lahore Division” shall be omitted; and, for sub-clause (ii), the following shall be substituted:

“(ii) Lord Mayor of Metropolitan Corporation Lahore;”.
