



WASA TENDER NOTICE

Sealed tenders for work mentioned below are invited from WASA approved contractors who have deposited the renewal fees for the year 2023-24, so as to reach the undersigned on the date given below, when the bids properly submitted will be opened, read and recorded. Tender documents can be obtained from the office of the undersigned against written request accompanied with attested copies of enlistment/ upto date renewal letters, PEC License authority letter of contractor/firm, Identity Card of contractor Managing partners of the firm along with registered power of attorney and get the Challan of prescribed tender fee located at F-Block LDA Avenue-I Housing Scheme, Lahore.

Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.

Tenders can be purchased upto date 22-01-2024.

Tender will be received in the office of the undersigned on 24-01-2024 upto 9:30 am and opened on same day on 10:00 am thereafter in presence of intending contractors or their representatives. Work order and execution of work depends upon the release of funds.

Conditional tender will not accepted. Bid Security will be 2% of the estimated price in shape of DCR/CDR. Tender without bid security will not be accepted (2014 PPRA Rule 27). The bidding documents are available immediately after publication (2014 PPRA Rule 25(1)). No tender will be accepted which is received telegraphically or post. No tender will be issued on the date of receipt of tender. The bid will be valid for the 30 days. Tender will be issue after depositing the tender fee. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal Under Punjab PPRA Rule (2014 Rule-35).

(For R&M Works) Payment to Contractor can be delayed upto one (01) year or may be more, as the payment is to be made by WASA own source and WASA Revenue Recovery.

Note: In case the total tendered amount is less than 5% (Five) of the approved estimated (DNIT) amount, the lowest bidder will have to deposit additional performance security from the Scheduled Bank ranging from 5% to 10%.
