Local Government and Community Development Department, Government of the Punjab, Lahore, invites bids through E-Procurement from registered / incorporated firms, suppliers, who are registered with Sales Tax and Income Tax Department and maintaining their own independent offices, to participate in the bidding process as per PPRA Rules, for procurement of Office Stationary / Computer Stationary / Printing & Publication, Cost of Other Stores and Others items during the current financial year 2024-25.

TERMS & CONDITIONS

The intending bidders participating in the bidding shall provide the following document along with their Technical Bids:-

- Bid Security i.e. 5% of total estimated cost in the form of Bank Draft / Pay Order / CDR in favour of Section Officer (General), LG&CD Department, Punjab Civil Secretariat, Lahore, may be submitted in the office of undersigned upto 02.09.2024 failing which the bid shall be rejected.
- Minimum two (02) years business history from the date of authorization.
- An affidavit on stamp paper submitting that neither the Company / firm has been blacklisted on any grounds whatsoever nor is being proceeded against or not involved in litigation. This certificate shall remain operative till the finalization of the procurement.
- Bank Certificate / Statement / Balance Sheet, Financial Soundness.
- Company Profile.
- General Sales Tax Number.
- Proof of NTN and Income Tax Payee.
- Professional Tax.
- Firm Registration.
- Two years audit report must be attached along with technical bid document.
- If Purchase Committee considered, the successful bidders are bound to supply the sample of items for which they have quoted the lowest rates.

INSTRUCTIONS FOR BIDDERS

- This procurement will be governed by the Punjab Procurement Rules, 2014 (amended time to time) upto date.
- Bid Document containing details of above requirements will be available at the PPRA website and E-PADS immediately after the publication of Tender Notice.
- Procuring Agency may reject all the bids any time prior to acceptance of any bid as laid down in Rule 35 of the Punjab Procurement Rules, 2014 (amended time to time) update.
- All the interested bidders are advised to submit all the required documents by 05.09.2024 After this, bidding documents shall not be considered.
- The technical bids will be opened on the day, after completion of E-Procurement procedure by PPRA, in presence of the authorized representatives of the firms and after approval of the technical bids by the Purchase Committee.
- After the approval of Purchase Committee, the date and time for opening the financial bid will be communicated to the qualified bidders.
- If the day of submission / opening of bids is declared as holiday the bids will be opened on the next working day.
