



| 10. | Proposed 25-12.18 | | A CNG Station may not be located within 0.46 mile (0.75 km) of the site of an existing or approved CNG Station unless the CNG Station and the other such site or sites are located on the opposite side of a street having a right-of-way of not less than 100 ft. (30.48m) and a dividing median strip. |


