E-TENDERING NOTICE

1. Rawalpindi Development Authority (RDA), Rawalpindi intends to tender out the following scheme through E-Tendering vide notification No.SO(1&C-1)5-4/2024 dated 09.05.2024. All contractors who are registered with Pakistan Engineering Council (PEC) for the financial year 2024-25 in relevant category and having valid registration with FBR and PRA having (active filer NTN & PNTN) can participate in Open E-Tendering system upon registration with EPADS. **Single Stage One Envelope** procedure will be adopted strictly in accordance with PPRA Rules, 2014. Contractors can participate in E-Tendering after fulfilling terms & conditions given below:

2. The Contractors / Firms have to be registered on Punjab PPRA website (www.punjab.eprocure.gov.pk). Any information/ procedure regarding registration can be seen / obtained from website ppra.punjab.gov.pk/e-procurement.
3. All intending contractors/firms have to prepare and upload the bid in accordance with instructions in bidding documents and must be submitted on E-PADS on and before **07.04.2025** not later than **12:00 P.M.** Submission of hard copies of bid shall not be accepted.
4. All intending contractors/firms have to fill rates against each items of work and upload bids in PDF form alongwith complete bidding documents on the same website upto half hour before the opening date and time of tender. (i) **PEC Certificate** valid upto **June, 2025** (ii) **Work Orders & Completion Certificate**, “(issued by the Engineer In Charge) of at least two similar nature projects of cost value, equal to or more than 50% of the estimated cost in last 03 years completed by firms” has to be uploaded alongwith the bid on EPADS and submitted to the tender opening committee in hard form (except Financial bid) by **07.04.2025 till 12:00 P.M.** before the opening of bids otherwise the firm / contractor will be disqualified in presence of tender opening committee. After filling the bids through EPAD by **07.04.2025 till 12:00 p.m.** interested bidders or their representatives shall attend the office of undersigned. Tenders will be opened on the same day at **12:30 p.m.** in the presence of the Committee.
5. The Bid Security / Earnest Money in the form of Bank Guarantee generated from firm’s account clearly indicating the name of firm of any schedule Bank in favour of the Director (Admn & Finance), RDA @ 5% of the estimated cost shall be uploaded on EPADS in soft copy and hard copy of the same (In Original) shall be submitted to the office of Dy. Director (Engineering-II) by **07.04.2025 till 12:00 p.m.** otherwise bid shall be rejected.
6. Rates & amount should be filled in figures as well as in words and bids should be sealed / signed as per general directions given in the bidding documents.
7. Conditional Bids & Bids not accompanied with earnest money @ 5% of estimated cost in shape of CDR, Bank Draft, Cashier Cheque or Bank Guarantee any scheduled Bank in favor of Director (Admin & Finance), RDA will not be entertained.
8. The bidder shall be required to quote their rates against each entry/ item of DNIT/BOQS in their financial bids. Bid quoted in percentage (%) of estimated cost shall be rejected.
9. If the e-bid or proposal including record submitted on the E-PADS found corrupt, un-readable or contain virus, the e-bid or proposal shall rejected as per **Regulation-8(4) OF PPRA Regulations-2024**.
10. The procuring agency may reject all bids or proposal at any time prior to acceptance of a BID or proposals under PPRA Rule-35 (Rejection of Bids).
