





1. The intending bidders shall submit signed stamp documents including technical & financial bids online through E-PADS portal by or before **October 29, 2025 at 12:00 P.M.** Manual bid is not acceptable.

Technical proposals will be opened on the same day on **October 29, 2025 at 12:30 P.M** through E- PADS in the presence of the procurement committee & bidders or their authorized representatives who may wish to attend the tender technical opening. After the technical evaluation, financial proposals of only technically qualified bidders shall be opened on a date/time to be announced subsequently.
3. The original instrument of bid security amounting to Rs. 5,00,000/- in the form of CDR in favor of "**Director Admin & Finance, MULTAN DEVELOPMENT AUTHORITY (MDA), MULTAN**" must be reached in procuring agency office of "**Director Admin & Finance, MULTAN DEVELOPMENT AUTHORITY (MDA), MULTAN** half an hour before opening time of Tender.
4. The financial proposal shall be inclusive of all applicable taxes.
5. The companies/ firms/ sole proprietors must have valid registration certificate for Income Tax (NTN) & PRA.
6. Incomplete proposals shall not be considered.
7. The bid validity period shall be 90 days from the last date for submission of the tender.
