NOTIFICATION

No.SO(CAB-I)2-21/2012.- In exercise of the powers conferred under Article 139 of the Constitution of the Islamic Republic of Pakistan read with rule 49 of the Punjab Government Rules of Business 2011, Governor of the Punjab is pleased to make the following amendments in the Punjab Government Rules of Business 2011, with immediate effect:

AMENDMENTS

In the Punjab Government Rules of Business 2011:

1. In First Schedule:

(a) at Sr. No. 4 [Colonies Department], in column 3, under the heading "**Head of Attached Department**", for the existing entry, the following shall be substituted:

"Director General, State Land Management and Katchi Abadis.";

(b) at Sr. No. 6 [Consolidation of Holdings Department], in column 2, under the heading "**Secretariat Department**", for the existing entry, the following shall be substituted:

"Consolidation of Holdings, Settlement and Land Acquisition Department"; and

(c) after Sr. No. 38B, in columns 1, 2, 3 and 4, the following shall be inserted:

Sr. No.	Secretariat Department	Head of Attached Department	Autonomous Bodies & Companies
"38C	Taxes Department	Director General of Taxes.	"

2. In Second Schedule, under the heading "**BOARD OF REVENUE**":

(a) under sub-heading (a) "**COLONIES DEPARTMENT**", after Sr. No. 9A, the following shall be inserted:

"9B. State land management.

9C. Mapping and digitalization of State land.

9D. Prevention of encroachment on State land and its retrieval.";

(b) for sub-heading (b) "**CONSOLIDATION OF HOLDINGS DEPARTMENT**", the following shall be substituted:

"(b) **CONSOLIDATION OF HOLDINGS, SETTLEMENT AND LAND ACQUISITION DEPARTMENT**";

(c) under sub-heading (b), so substituted, for Sr. No. 4, the following shall be substituted:

"4. Settlement of lands and matters ancillary thereto.

5. Administration of the following laws and the rules framed thereunder:

i. The Land Acquisition Act, 1894 (I of 1894).

ii. The Punjab Survey and Rectangulation of Lands Ordinance, 1959 (XXXIV of 1959).

iii. The Punjab Consolidation of Holdings Ordinance, 1960 (VI of 1960).";

(d) under sub-heading (c) "**DISASTER MANAGEMENT DEPARTMENT (DMD)**", after Sr. No. 8, the following shall be inserted:

"8A. Embankment and drainage works.";

(e) under sub-heading (d) "**REVENUE DEPARTMENT**":

(i) the existing entries at Sr. Nos. 9, 17, 24, 54, 60, 61, 62, 63, 64 and 67 shall be omitted;

(ii) at Sr. Nos. 51 and 58, for the words "Consolidation of Holdings department", the expression "Consolidation of Holdings, Settlement and Land Acquisition Department" shall be substituted; and

(iii) at Sr. No. 72, the existing entries at item Nos. i., xi., xii., xvi., xxvi., xxxvii., lxvii. and lxxii. shall be omitted; and

(f) after sub-heading (d) "**REVENUE DEPARTMENT**", the following shall be inserted:

"(e) **TAXES DEPARTMENT**

1. Legislation, policy formulation and sectoral planning.

2. Court fees.

3. Finalization and enforcement of District Collector (DC) Valuation Tables.

4. Registration of deeds and documents and registration fee.

5. Stamp duty.
6. Supervision of e-Stamping system.
7. Tax on agricultural income.
8. Tax on transfer of immovable property.
9. Transfer of property.
10. Administration of the following laws and the rules framed thereunder:
 - i. The Court Fees' Act, 1870 (VII of 1870).
 - ii. The Transfer of Property Act, 1882 (IV of 1882).
 - iii. The Revenue Recovery Act, 1890 (I of 1890).
 - iv. The Stamp Act, 1899 (II of 1899).
 - v. The Registration Act, 1908 (XVI of 1908).
 - vi. The Punjab Copying Fees Act, 1936 (V of 1936).
 - vii. The Punjab Land-Revenue Act, 1967 (XVII of 1967).
 - viii. The Punjab Agricultural Income Tax Act 1997 (I of 1997).
11. Matters incidental and ancillary to the above subjects."
