NOTIFICATION

No.1914-2025/ 8131 Admn(I). In pursuance of approval of the Chief Minister Punjab vide No. CMO/I/250603/02112 dated 04.06.2025 regarding "Restructuring of the Board of Revenue" and in exercise of powers conferred under the Punjab Government Rules of Business, 2011, whereby Secretary of the department, Government of the Punjab, is competent to issue orders, an "Audit, Inspection & Monitoring (AIM) Wing" is created in the Board of Revenue with the following specific functions:

1. Creation of Audit, Inspection & Monitoring (AIM) Wing.

- i. The Audit, Inspection & Monitoring (AIM) Wing is established under the supervision and control of Member, Audit, Inspection & Monitoring (AIM), BOR
- ii. Existing Colony Audit Cell, Inspectorate of Stamps, Tehsildars (Audit & Inspection) and Inspection Section are transferred to the AIM Wing.
- iii. Settlement & Rehabilitation Audit Cell, Land Acquisition Audit Cell and Land Commission Land Audit Cell are established under AIM wing
- iv. Audit, Inspection and Monitoring staff from the existing departments/wings of BOR are transferred to the AIM Wing
- v. All support staff shall be posted from the existing strength of the Board of Revenue

2. Job Description

- i. Supervision and audit of Board of Revenue, Divisional, District and all other revenue offices
- ii. Superintendence of Annual Audit Reports and settlement of audit paras of PAC/DAC/SDAC
- iii. Meetings regarding audit, inspection and monitoring of all revenue offices
- iv. Supervision and Implementation of inspection reports
- v. Inspection & Monitoring of revenue case management and performance of revenue courts under BOR
- vi. Audit, inspection & monitoring of digital transactions and processes under BOR
- vii. Any other duty assigned by the Senior Member, Board of Revenue

3. Placement of Directorate of Land Record under AIM Wing

Directorate of Land Records, BOR, is placed under the AIM Wing.

4. Performance Evaluation

Performance evaluation of all the officers/officials of AIM wing shall be made/furnished to SMBR by Member Audit, Inspection and Monitoring BOR
