E-TENDERING NOTICE

The tender for the following schemes are invited from engineering firms/contractors on the item rates basis as per current market rate system 2nd Bi annual period 2024 as per PPRA E-Tendering System, in line with relevant PPRA Rules (amended updated). According to these Rules all the firms/contractor can participate in tendering process with following terms and conditions:

1. The intending Contractors/Firms who have been registered with Pakistan Engineering Council in the relevant category/code may participate.
2. The Contractors/Firms has to be registered on Punjab EPADS website (www.punjab.eprocure.gov.pk). Any information/procedure regarding registration can be seen/obtained from website ppra.punjab.gov.pk/e-procurement.
3. The intending Contractors/Firms have to upload the earnest money in the shape of CDR in favor of Director Finance & Admin, MDA Multan @ 2% of the estimated/bid cost and fill rates against item of work on the same website upto half hour before the opening date and time of opening of tender. However, original CDR has to be submitted to the tender opening committee on the same day, half hour before the opening of bids otherwise, the firm/contractor will be disqualified in presence of tender opening committee.
4. After filling the bids on website, contractors may attend the office of Director Engineering, MDA Multan on 03-12-2024 at 01:00 P.M., where successful bidder will be announced in the presence of Tender Opening Committee.
5. In case of submission of any fake information/document such as CDR/receipt, the Contractor/Firm will be disqualified from the current tendering procedure and will be black listed to participate in any tendering process of MDA Department. Further recommendation to PPRA and PEC will also be made against such firm/contractor for appropriate action/black listing.
6. The bidder shall submit hard copy of financial instruments in addition to the soft copy uploaded on the E-PAD as bid security. The bid security shall only be released upon the hard copy.
7. Bid quoted in percentage without quoting rate against each item of detail notice for invitation to tender (DNIT) or bill of quantities (BOQs) shall be considered as financial non responsive.
8. According to prevailing rules of Finance Department, in case the amount of work exceeding Rs. 50,000/- (M), 5% of the bid price will be applicable as **Performance Guarantee** in shape of Call Deposit Receipt or Bank Guarantee from any schedule bank in favor of Executive Engineer MDA Multan in addition to quality assurance security.
