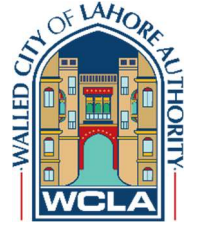

E-TENDERING NOTICE

The Walled City of Lahore Authority – WCLA (the “Employer”) intends to E-Tendering for the following project through newly introduction E-Procurement / EPADS.

1. All Contractors who are registered with Pakistan Engineering Council (PEC) and specialized code BC-02 having relevant experience **of conservation projects** can participate in Open E-Procurement / EPADS System. Procurement procedure strictly be adopted in accordance with PPRA Rules 2014 (with up-to-date amendments). Contractors can participate in E-procurement / EPADS after fulfilling following terms & conditions.
2. Contractor may register firm on website EPADS / <https://eprocure.gov.pk> of Public Procurement Regulatory Authority (PPRA) by submitting their requisite information.
3. After registration on E-Tendering website **EPADS / <https://eprocure.gov.pk>** contractor of eligible categories may participate in E-Procurements.

4. Single Stage Two envelopes bidding procedure shall be adopted. Contractor / bidder has to upload scanned copy of technical bid and financial bid on EPADS. Contractor has to quote online rates of each item, must be submitted on EPADS on or before 06.01.2026, not later than 02:00PM. The rates quoted online by the contractor will be announced on same date at 02:30 PM. Manual Bids shall not be accepted.
5. Contractor may generate the Bid Security @2%, amount mentioned against the estimated cost of any scheduled bank. contractor / bidder has to upload scanned copy of Bid Security/Call Deposit Receipt (CDR) @2% of the estimate cost of any scheduled bank, Original CDR must be submitted in favor of the Director General, WCLA, undersigned on tender opening date before closing time. Otherwise, the contractor will be declared as disqualified in the presence of Tender Opening Committee.
6. In case of false information, fake Bid Security (CDR), the contractor will be liable to disqualify as per PPRA Rules and will not be eligible to participate in upcoming tender of WCLA, Government of the Punjab. Further his case will be forwarded to PEC and PPRA for initiation of Strict Legal Action. Please note that the subject procurement shall be carried out through **EPADS** of Punjab Procurement Regulatory Authority (PPRA) only. **All interested applicants are required to register on EPADS to be eligible for participation.** Tender Notice / Tender document containing detailed requirements, terms and conditions is available for the registered bidders on EPADS at [Punjab.eprocure.gov.pk](http://punjab.eprocure.gov.pk) and Punjab Procurement Regulatory Authority (PPRA) website <http://ppra.punjab.gov.pk>. and Walled city of Lahore Authority (WCLA) website <https://walledcitylahore.gov.pk/>
