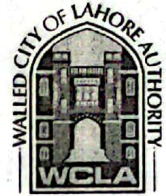

### TENDER NOTICE

**ELECTRICAL AND ILLUMINATION WORK OF PROJECT TITLED "THE RESTORATION OF MALL ROAD AND HISTORIC ZONES OF LAHORE (WAZIR KHAN BARADARI, NCA TOLLINTON MARKET AND MUSEUM)".**

1. Following tender is invited based on single stage two envelope procedure from the eligible firms / contractors registered / renewed with Pakistan Engineering Council (PEC) in the relevant category.

2. Procurement shall be carried out through E-Procurement (EPADS). The E-Tender Notice & Bidding Document are available on EPADS and PPRA Website. If the E-Bid or proposal including record submitted on EPADS found corrupt or contain virus or unreadable, the E-bid or proposal shall be rejected as per Regulation 8 (4) of PPR, 2024.
3. The Bidder shall submit E-bid through uploading of PDF file on EPADS as per Regulation-6 (4) of PPR, 2024 and also submit the original bid to procuring agency.
4. The bid shall be a **Single Stage Two Envelope Bidding Procedure** through Open Competitive Bidding Method and bid shall be evaluated based on least cost method.
5. The prospective bidders are required to submit earnest money in the form of a CDR/Pay Order/ Bank Guarantee of any scheduled Bank @ 2% of the estimated cost. The contractors / bidders shall produce the original CDR/Pay Order/ Bank Guarantee in the name of **Director General, WCLA Lahore** accompanying the letter head of the applicant / firm **on or before** the closing time of the bid, otherwise the online bid submitted will not be entertained. The online submitted bids / tenders will be opened on E-PADS on fixed date & time in committee room of Walled city of Lahore Authority. The online submitted bids unaccompanied with scanned copy of earnest money shall not be accepted.
6. The Bid document comprising Proposal prepared in accordance with instructions in bidding document shall be uploaded on E-PADS on or before **04-11-2025** by **01:00 PM**. Technical Bids will be opened on same day at **01:30 PM** by the committee in presence of the bidders / their authorized representatives and financial bid will be opened after Technical Evaluation.

7. Bidder Shall submit bidding documents duly signed & stamped by the authorized representative.
8. Price schedule/Bid Security be submitted on the letter head of Contractor.
9. The procuring agency may reject all bids or proposals at any time prior to acceptance as per Punjab Procurement Rules 2014 (Rule 35).
10. For obtaining any further information or clarification, please feel free to contact the Procuring Agency.
11. There must be no cutting / amendment in bid quoted by contractors through electronic system.
12. No telephonic / conditional tender and without earnest money will be entertained.
13. All relevant rules will be applicable.
