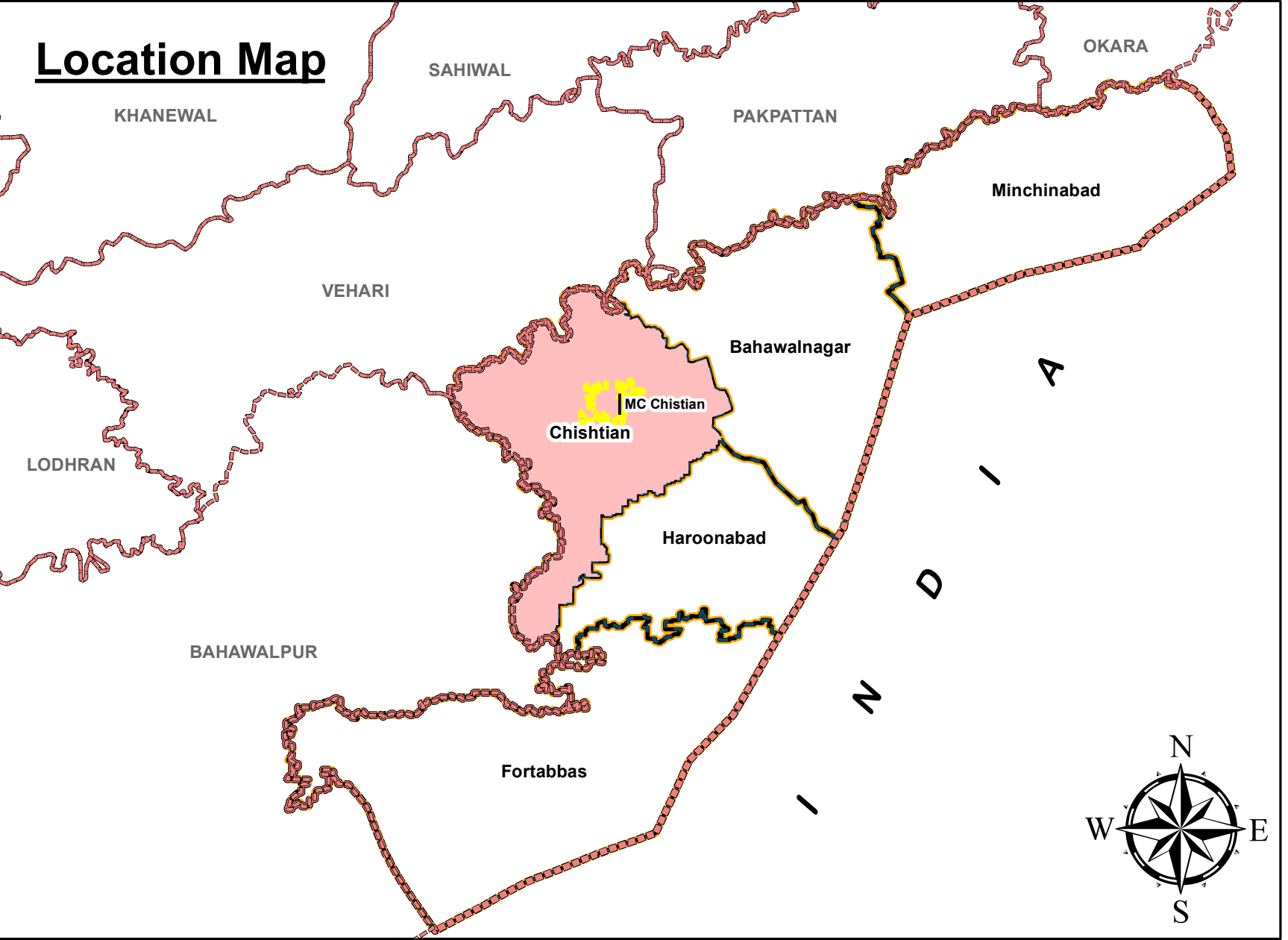
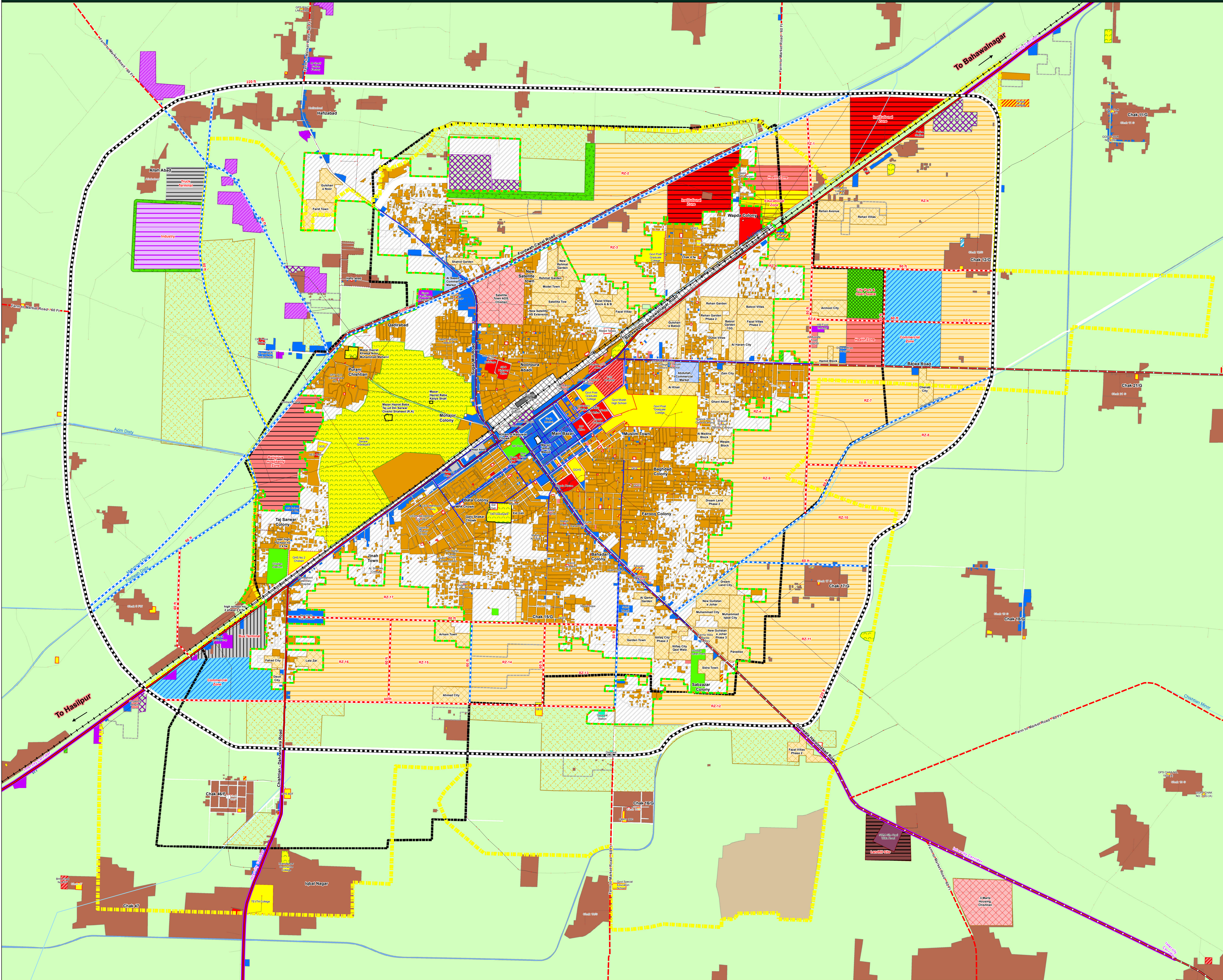


Site Development Zone (SDZ) Structure Plan of Municipal Committee Chishtian (2025-2045)
